OF

**ARTICLE I

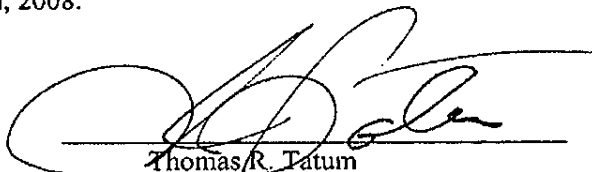

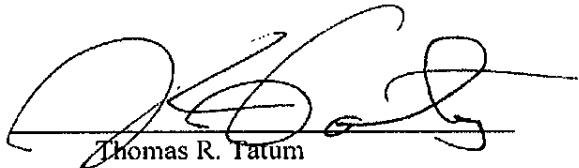
