ARTICLES OF INCORPORATION

OF

ARTICLE ONE

NAME

The name of this corporation is:

GENESIS ACCOUNTING SYSTEMS, INC.

The principal place of business of this corporation shall be 2030 S.W. 122 AVENUE, SUITE 18, MIAMI, FLORIDA 33175.

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON FILING WITH THE SECRETARY OF STATE.
