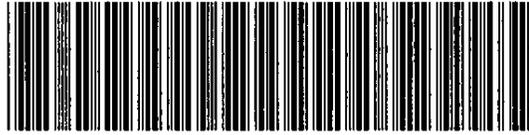

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation within the State of Florida.

ARTICLE I

The name of the Corporation is: Inasmuch Properties, Inc., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

ARTICLE II

The street address of the principal office of the Corporation is: 1007 West Wright Street, Pensacola, Florida 32501-3766.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, with 250 shares to Vera G. Sullivan and 250 shares to Joseph L. Sullivan. All Shares shall be identical with each other in every respect and the holders of said Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV

The initial street address of the Corporation's registered office is: 1007 West Wright Street, Pensacola, Florida 32501-3766. The initial registered agent for the Corporation at that address is: Vera G. Sullivan.

ARTICLE V

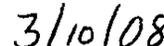
ARTICLE VII
