

#### ARTICLES OF INCORPORATION

#### MAJOR INSURANCE ADJUSTERS OF FLORIDA, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

# ARTICLE I Name and Address

The name of the Corporation shall be MAJOR INSURANCE ADJUSTERS OF FLORIDA, INC., and its mailing address is 2032 Whitney Drive, Clearwater, Florida 33760.

# ARTICLE II Purpose and Powers

- Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.
- Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

## ARTICLE III Term of Existence

The Corporation shall have perpetual existence. Corporate existence shall commence on the date of filing of these Articles of Incorporation.

### ARTICLE IV Capital Stock
