**NAME**

The name of this corporation is RTQ, INC.

**ARTICLE II**

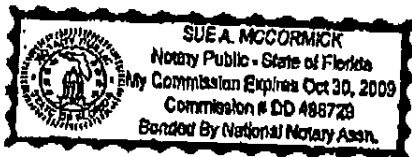
