



We, the undersigned, hereby associate ourselves for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of **RUKE, INC.**, and hereby set forth and declare:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be **RUKE, INC.**

ARTICLE II - EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK


ARTICLE VIII - BYLAWS


