Pursuant to Section 607.1007 of the Florida Business Corporation Act, Black and Denim Incorporated (the "Corporation"), a Florida corporation, desires to amend and restate the Corporation's Articles of Incorporation and hereby certifies:

FIRST: The Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on March 17, 2008, Document No. P08000028012.

SECOND: These Amended and Restated Articles of Incorporation, which supersede the original Articles of Incorporation and all amendments to them, were adopted by all the directors and shareholders of the Corporation on September 17, 2018. To effect the foregoing amendment and restatement, the text of the Articles of Incorporation is hereby restated and amended as set forth below in full:

**ARTICLE I. NAME**

The name of the Corporation is: Black and Denim Incorporated

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal business office and mailing address of the Corporation is 1901 East 7<sup>th</sup> Avenue, Tampa, Florida 33605.

**ARTICLE III. CAPITAL STOCK**

The total number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any time is 100,000 shares of common stock, having a par value of \$.01 per share.

**ARTICLE IV. REGISTERED OFFICE AND AGENT**
