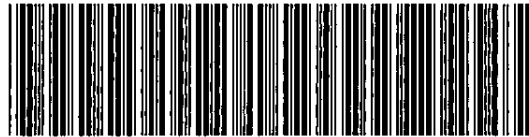


To Whom It May Concern:

INITIAL REGISTERED OFFICE AND AGENT**




