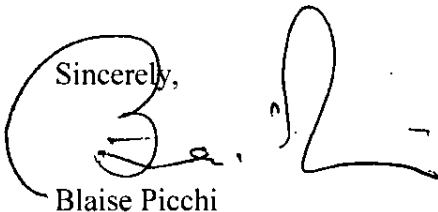

**ARTICLE I. CORPORATE NAME AND ADDRESS.**

The name of the corporation is **GOES WITHOUT SAYING, INCORPORATED** and its initial principal office is 1386 Coronado Road, Weston, Florida 33327.

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.

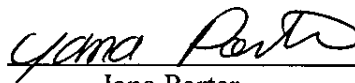
