ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

ARTICLE I

Article I of the Articles of Incorporation is hereby amended to read as follows:

The name of the corporation is COBIAN INTERNATIONAL GROUP, INC.


ARTICLE III


