**ARTICLES OF INCORPORATION

I, the undersigned, hereby subscribe to, acknowledge and file the following Articles of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation is: **JUST ANOTHER TASTE QUISINE, INC.** a Florida Corporation.

**ARTICLE II - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under Chapter 607 Florida Statutes.

**ARTICLE III - CAPITAL STOCK**

This corporation is authorized to issue 100 shares at \$1.00 a share, which shall be designated as "Common Shares." All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at the just valuation to be fixed by the Board of Directors.

**ARTICLE IV - VOTING**

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the Board of Directors, each with one vote to be cast.

**ARTICLE V - TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

#### **ARTICLE VI - STATUS**

This corporation elects Sub-Chapter "S" status according to applicable State and Federal Laws and will file a Form 2553 with the Internal Revenue Service.

#### **ARTICLE VII - TERMS**

This corporation shall commence at the time of filing of these articles and shall have perpetual existence.

#### **ARTICLE VIII - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which **he/she** already holds, shall have the right to purchase **his/her** pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which it is offered to others.

#### **ARTICLE IX - PRINCIPAL OFFICE AND RESIDENT AGENT**

**ARTICLE X - INITIAL BOARD OF DIRECTORS AND INCORPORATORS**

This corporation shall have at least one (1) director initially with the exact number of directors to be specified by the shareholders from time to time unless the shareholders shall by a majority vote, determine that the corporation be managed by the shareholders.

## **ARTICLE XII - INDEMNIFICATION**

Every person who now is or hereafter shall be a Director or Officer of the corporation shall be indemnified by the corporation against all costs and expenses (including counsel fees) hereafter reasonably incurred by or imposed upon him in connection with, or resulting from, any action, suit or proceedings of whatever nature, to which **he/she** is or shall be made a party by reason of his being or having been a Director or Officer of the corporation (whether or not **he/she** is a Director or Officer of the corporation at the time **he/she** is made a party to such action, suit or proceeding, or at the time such cost or expense is incurred by or imposed upon **him/her**) except in relation to matters as to which **he/she** shall be finally adjudged in such action, suit or proceeding to have been derelict in the performance of **his/her** duties as such Director or Officer. The right of indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled to as a matter of law.

## **ARTICLE XIII - DISCLOSURE**

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in no way be affected or invalidated by the fact that any of the Directors of this corporation are pecuniarily or otherwise interested in, or are directors, or officers of, such corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that **he/she** or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof. Any director of this corporation who is also a director or officer of such corporation, who it is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation.

#### **ARTICLE XIV - BY LAWS**

The Board of Directors of this corporation may provide such By-Laws for the conduct of the business of the corporation and the carrying out of its purposes as such Directors may deem necessary from time to time. Upon notice properly given, the By-Laws may be amended, altered or rescinded by majority vote of the shareholders present at any regular or special meeting called for that purpose, subject to any limitations set forth in the laws of Florida concerning corporate action that must be authorized or approved by members of the corporation.

#### **ARTICLE XV - AMENDMENTS**

An amendment to these Articles of Incorporation may be proposed by and amended by any one member of the Board of Directors of the corporation.


#### **ARTICLE XVI - INDEBTEDNESS**
