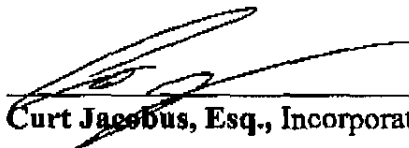
ARTICLE IX - BYLAWS
