**ARTICLES OF INCORPORATION
OF
Demesmin Insurance Agency, Inc.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is *Demesmin Insurance Agency, Inc.*. The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE II

The existence of the Corporation shall begin on *March 12th, 2008*.

ARTICLE III

The street address of the principal office of the Corporation is *1901 North Pine Island Road, Plantation, Florida 33322*.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is Five-Hundred (500), all of which shall be Common Shares.
