ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is HIGH STAKES CHARTERS, INC., and its principal place of business shall be located at 6511 Maloney Avenue, Lot 6, Stock Island, Key West, Florida 33040, and the mailing address is the same.
