**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SEO BRAND CORP**

In accordance with shareholders' approval of a proposal to amend the Company's Articles of Incorporation to increase the number of authorized shares of the Company's common stock, no par value, from 2 to 500 duly executed by a majority of the votes cast by the shareholders of SEO BRAND CORP entitled to vote thereon, and ratification of such action by the Company's Board of Directors, the Company's Articles of Incorporation are hereby Amended as follows:

ARTICLE III CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to have outstanding at any one time is 500 (Five Hundred) shares, no par value. The 500 shares of no par value capital stock of the Corporation shall be designated as follows:

- 500 common shares

Except as amended above the remainder of the Company's Articles of Incorporation shall remain unchanged, and are hereby ratified and confirmed.

The foregoing Amendment to the Articles of Incorporation was duly adopted on March 28, 2018 by a majority vote of the holders of the Corporation's common stock, no par value, no Preferred Shares being outstanding, and approved by a sufficient number of votes pursuant to the Florida Statutes.

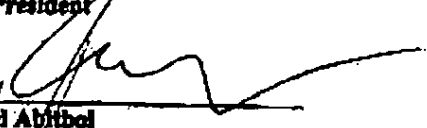
