Article I of the Articles of Incorporation of Floridian Custodial Services, Inc. is hereby amended to read in its entirety as follows:

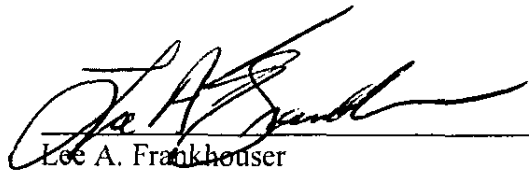
**ARTICLE I**
