ARTICLE I

The name of this corporation is: GRAND HOTEL GROUP INC.

ARTICLE II

This corporation shall have perpetual existence.

The business to be transacted by this corporation is real estate investment, development, hotel operations and related matters. This corporation shall have the powers as enumerated in Section §607.011 of the Florida Statutes, as they presently exist, together with any and all amendments to said Section.

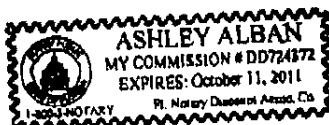
