Pursuant to the provisions of Section 607.0202 of the Florida Business Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I - NAME

The name of the corporation is SP One Holdings, Inc.

ARTICLE II - ADDRESS

The principal office and mailing address of the corporation is 1205 West Swann Avenue, Tampa, Florida 33606.

ARTICLE III - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of common stock, par value \$0.01 per share.

ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT

The name and address of the person signing these Articles of Incorporation as Incorporator is as follows:



The foregoing right of indemnification shall not be exclusive of any other rights to which any Directors, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.


