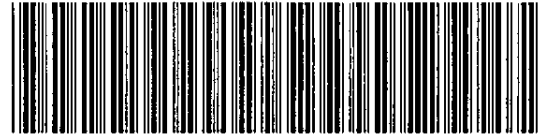

SECOND: The document number of the corporation is P08000030679.


THIRD: The Articles of Incorporation were filed on March 24, 2008.


