**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

FIRST: The name of the Corporation is 1754 NW Inc.


SECOND: Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following substituted therefor:
