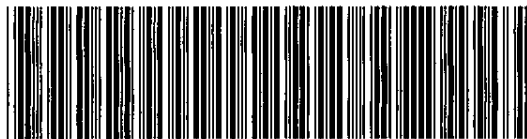

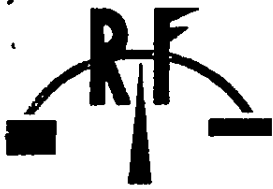

**ARTICLE I. CORPORATE NAME**

#### ARTICLE IX. AMENDMENT


