ARTICLE I - NAME

The name of the Corporation is Eastside Supply, Inc.,

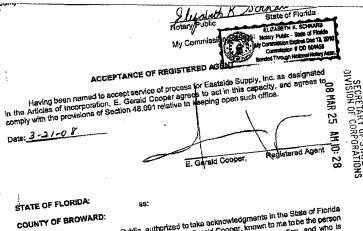
