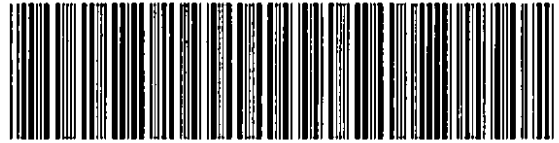



NOW, IT IS HEREBY AGREED as follows:


1. The Transferor transfers absolutely all title over the Shares to the Transferee in consideration of the amount of \$1.00
