The undersigned, acting as Incorporator of a Florida corporation under the Florida SEERETARY OF STATE Business Corporation Act, Chapter 607 of the Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

#### ARTICLE I NAME
