My name is Gene Church, and I am listed as the incorporator of Serenity House Gulf Coast, Inc. I inadvertently originally incorporated this organization as for-profit, when I intended it to be non-profit. I then attempted to file Articles of Correction to change its status to non-profit; Ms. Brown notified me that this was not the appropriate manner of correcting this mistake, and that I would need to dissolve the for-profit organization, and re-incorporate as a non-profit.

I drafted the Articles of Dissolution for the for-profit corporation, but failed to submit it before attempting to file online for non-profit status. I paid \$70 for this. This is how Ms. Poole got involved.

There are times that my attempts to fix a problem create new ones!

I have enclosed the Articles of Dissolution, along with permission for the new corporation to use the name "Serenity House Gulf Coast, Inc." Finally, I have enclosed the Articles of Incorporation for the non-profit that I wish filed in this matter.

I have submitted previously funds totaling \$210.00, comprised of \$87.50 paid online through Link2gov on or about March 26, 2008 (payment ID 22959538), a \$52.50 check received by Ms. Brown on or about April 14, 2008, and \$70.00 filed online to Ms. Poole on or about May 22, 2008. It appears that I owe \$35.00 for the corporate dissolution of the for-profit corporation, and \$70.00 for the non-profit incorporation. I believe that this would leave me eligible for a credit of a remaining balance, but if this is not the case, please let me know, as it is important that I get this matter handled as soon as possible.
