ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Overflow Auto Brokers, Inc.

ARTICLE II - PRINC)PAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 8254 Via Verona, Orlando, Florida 32836, which shall also be the mailing address of the Corporation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is two hundred thousand (200,000) of which one hundred thousand (100,000) shares having a par value of One Dollar (\$1.00) per share shall be shares of Class A voting common stock and one hundred thousand (100,000) shares having a par value of One Dollar (\$1.00) per share shall be shares of Class B non-voting common stock.

Accordingly, each share of common stock, both Class A voting and Class B non-voting, shall receive equal dividends if and when declared by the Board of Directors, and in the event of any liquidation, dissolution or winding up of this Corporation, the assets and funds of this Corporation shall be paid to and distributed equally among the holders of both the Class A voting and Class B non-voting common stock in proportion to the number of shares held by the holders of such shares.
