#### ARTICLES OF INCORPORATION

The undersigned incorporator, being authorized to execute and file these Articles of Incorporation, for the purpose of forming a Florida professional services corporation, pursuant to Chapters 607 and 621 of the Florida Statutes, hereby certifies that:

## ARTICLE I NAME

The name of the professional service corporation (hereinafter referred to as the "Corporation") is:

# ARTICLE V AUTHORIZED SHARES

The aggregate number of shares which the Corporation shall have the authority to issue is ONE THOUSAND (1,000) shares, all of which shares shall be common stock with a par value of \$.001 per share.

#### ARTICLE VI REGISTERED OFFICE AND REGISTERED AGENT

The Corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.
