ON 5/21/12 AN ELECTRONIC AMENDMENT WAS FILED CHANGING REGISTERED AGENT GABRIEL MERE TO MERCEDES LINARES WITH ADDRESS 1150 NW 72 AVE SUITE 220 MIAMI FLORIDA 33126. COINCIDENTALLY, THIS ADDRESS IS USED AS A PRINCIPAL ADDRESS FOR ANOTHER ENTITY NAMED SPIRIT MEDICAL CENTER INC WITH DOCUMENT NUMBER P10000074061 OWNED BY ANOTHER ENTIRELY DIFERENT PARTY.

ON 5/24/12, ANOTHER AMENDMENT WAS MADE REMOVING MERCEDES LINARES AND ADDING VICENTE ZAYAS AS THE CORP PRESIDENT OF FLORIDA PREMIUM BILLING & COLLECTION SERVICES CORP.

ADDITIONALLY, A CORPORATION WITH SIMILAR NAME AS MY CORP NAME WAS OPEN ON 5/29/12 NAMES " FLORIDA PREMIUM BILLING & COLLECTION INC" ( DOCUMENT NUMBER P12000049404). INCREDIBLY, THIS OFFICE IS LOCATED RIGHT IN FRONT OF MINE. WE WALKED IN TODAY TO VERIFY THE EXISTENCE OF THIS BUSSINESS AND THE SUITE NUMBER "21C" DOES NOT EXIST. WE CONTACT THE BUILDING MANAGER AND SHE CONFIRMED THAT THIS SUIT NUMBER IS OCCUPIED BY A RELIGIOUS GROUP.

AS A COLLECTION COMPANY, WE RECEIVED INSURANCE COMPANIES PAYMENTS FOR AROUND 80-100 THOUSAND DOLLARS WEEKLY BY US MAIL.

THE GROUP OF PEOPLE THAT TARGETED US ARE VERY MUCH INFORMED ABOUT THE MODALITY OF BUSINESS AND TRIED TO FORWARD THE MAIL TO A DIFFERENT ADDRESS OR TRY TO CONFUSED THE MAIL MAN TO DELIVERE PAYMENTS TO AFICTICIOUS BUSSINESS WITH SIMILAR NAME IN THE SAME AREA.

WE HAVE NOT CONFIRMED YET BUT THIS TYPE OF FRAUD MAY CAUSE OUR BUSSINESS A GROSS AMOUNT OF LOSSES FOR BETWEEN \$ 50,000-\$80,000 SINCE THEY CHANGED OWNERS NAME AND ADDRESSES FRAUDULENTLY. ITS ONLY A MONETARY LOSS, BUT EVEN WORSED, A NEGATIVE IMPACT OF OUR IMAGE TOWARDS OUR CLIENTS, WHICH EVENTUALLY THE PAYMENTS ARE FORWARD TO THEM.

WE HAVE FILED TODAY A POLICE REPORT WITH THE DORAL PD ( NUMBER DR120612011467 – OFFICER MARRERO) HE WILL FORWARD THE DETAILS TO THE POLICE INVESTIGATOR WHO WILL CONTACT US AS PER OFFICER.
