ARTICLES OF INCORPORATION CREATE YOUR DREAMS ENTERPRISES, INC.

OBMAS MILES I, the undersigned, hereby subscribe to, acknowledge and file the following Articles of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

<u>ARTICLE I - NAME</u>

The name of this corporation is: CREATE YOUR DREAMS ENTERPRISES, INC. a Florida Corporation.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under Chapter 607 Florida Statutes.

ARTICLE III - CAPITAL STOCK
