The undersigned subscriber to these Articles of Incorporation, a natural person to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I – NAME**

The name of the corporation shall be C Dawg Charters, Inc. The principal place of business of this corporation shall be 4630 29<sup>th</sup> Avenue South Gulf Port, FL 33711

**ARTICLE II – NATURE OF BUSINESS**

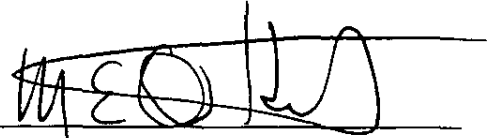
