

ARTICLES OF INCORPORATION
OF

ARTICLE I. CORPORATE NAME.

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

The street address of the Corporation's initial registered office is 6530 SW 70th Street, Trenton, Florida 32693, and the mailing address is 6530 SW 70th Street, Trenton, Florida 32693, and the name of the Corporation's initial registered agent at that office is Fate Seay.

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

ARTICLE V. INCORPORATOR.

ARTICLE VI. THE NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE VII. TERM OF EXISTENCE.

This Corporation shall have perpetual existence commencing upon the filing of these articles.

ARTICLE VIII. BOARD OF DIRECTORS.

This Corporation shall have two directors initially. The number of directors may be increased or decreased from time to time by By-laws adopted by the stockholders, but shall never be less than one.

ARTICLE IX. INITIAL DIRECTORS AND OFFICERS.

The names of the initial directors of this Corporation and their addresses are: Fate Seay, 6530 SW 70th Street, Trenton, Florida 32693; and Catherine F. Seay, 6530 SW 70th Street, Trenton, Florida 32693. Fate Seay shall initially serve as a Director, President, and Treasurer; and Catherine F. Seay

shall initially serve as a Director and Secretary. The persons named as initial directors and officers shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

ARTICLE X. AMENDMENT.


These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
