

# ARTICLES OF INCORPORATION

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of the corporation shall be MDR Ventures Corp.

## **ARTICLE II - COMMENCEMENT & DURATION**
