ARTICLES OF INCORPORATION

SUPREME INSURANCE & INVESTMENTS, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I (Name of Corporation)

The name of the corporation is Supreme Insurance & Investments, Inc. (the 'Corporation').

ARTICLE II (Corporate Existence)

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on March 24, 2008, and the Corporation shall have continuous and perpetual existence thereafter.

ARTICLE III (General Purpose of Corporation)

The general purposes for which the Corporation is initially organized are as follows:

To transact any lawful business for which Corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV (Authorized Shares, Par Value)

The aggregate number of shares which the Corporation shall have authority to issue is (100) shares. These shares shall consist of only one class, and that class shall be known as "common shares" of the Corporation. Each share shall have a par value of one dollar (\$1,00) per share.

ARTICLE V (Registered Agent and Address of Corporation)

The name of the initial registered agent of the Corporation shall be Gillard S. Glover (hereinafter the "Registered Agent") and the street address of the initial registered office of the Corporation shall be 5 Sawmill Court, Palm Coast, Florida 32164. To signify acceptance of appointment as registered agent, the Registered Agent has signed these Articles pursuant to Section 607.034, Florida Statutes.

ARTICLE VI (Initial Place of Business)

The street address of the initial principal place of business shall be 5 Sawmill Court, Palm Coast, Florida 32164.

ARTICLE VII (Board of Directors of Corporation)

The number of directors who shall constitute the initial board of directors of the Corporation shall be one (1). The name and street address of the person who is to serve as the sole member of the initial board of directors of the Corporation is:
