## ARTICLES OF INCORPORATION

OF

#### **ARTICLE I - NAME**

The name of the corporation shall be **MAX NUEBLER PAINTING, INC.** The mailing address for the corporation is 1834 Main Street, Sarasota, Florida 34236.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### **ARTICLE III - PURPOSE**

#### **ARTICLE X - REPLACING STOCK CERTIFICATES**

The date of commencement of this corporation shall be the date of the filing of these Articles of Incorporation with the Department of State, State of Florida.


