ARTICLES OF INCORPORATION OF SAGE DEVELOPMENT COMPANY

Pursuant to the provisions of Section 607.0202 of the Florida Business Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:.

ARTICLE I - NAME

The name of the corporation is SAGE DEVELOPMENT COMPANY.

ARTICLE II - ADDRESS

ARTICLE III - CAPITAL STOCK

The foregoing right of indemnification shall not be exclusive of any other rights to which any Directors, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.
