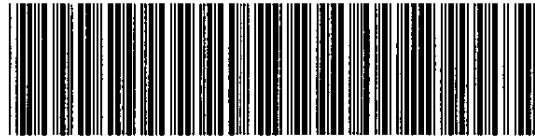

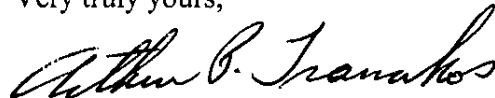

ARTICLES OF INCORPORATION

OF

LOCOMOTIVE, INC.

I.

The name of the corporation is "LOCOMOTIVE, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporation shall have perpetual duration.

IV.

The corporation is a corporation for profit and is organized for the following purposes:

- (a) To buy, sell, and/or manage real property for its own or other's account;

organized under the Florida Business Corporation Act.

The corporation may, upon adoption of a resolution by its Board of Directors, purchase its own shares to the extent of unreserved and unrestricted capital surplus available for said purchase.

XII.

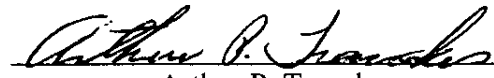
Any sale or other disposition of the shares of this corporation by its shareholders shall be subject to such restrictions as may be provided in the by-laws of the corporation.
