DAIMA'S CAFETERIA, INC., a corporation duly organized and existing under the laws of the State of Florida, hereby certifies as follows:

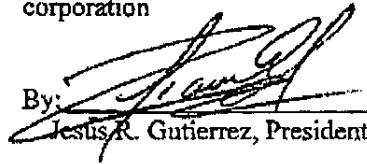
