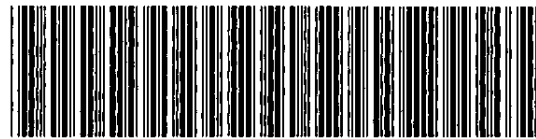

ARTICLES OF INCORPORATION

In compliance with the requirements of *Chapter 607, Florida Statutes (2007)*, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

EFFECTIVE DATE 4-1-2008

ARTICLE I

The name of the Corporation ("Corporation") is TOP GUN CUSTOM EXHAUST, INC.

ARTICLE II

The existence of the Corporation shall begin on April 1, 2008.

ARTICLE III

The street address of the principal office of the Corporation is 1415 Lemhurst Road, Pensacola, Florida, and at such other places as it may, from time to choose.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ONE THOUSAND (1,000) with a par value of ONE CENT (\$.01) per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for

each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 1415 Lemhurst Road, Pensacola, Florida 32507. The initial registered agent for the Corporation at that address is David Luther Woodward.

ARTICLE VI

The initial board of directors shall consist of one (1) member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names of the persons who will serve on the initial board of directors is David Luther Woodward.

ARTICLE VII

The shares of stock represented by this certificate have not been registered with the Securities and Exchange Commission under the Securities Act of 1933 or with any state agency regulating the offer and sale of securities. The sale or other disposition of the shares is restricted and any sale or other disposition may be conditioned on the receipt by the Corporation of an opinion of counsel satisfactory to the Corporation that the sale or other disposition can be legally made without registration under the Securities Act of 1933, or under any other federal or state law. By acquiring the shares represented by this certificate, the shareholder agrees with the Corporation that he or she will not

sell or otherwise dispose of any interest in the shares without registration or other compliance with all applicable securities laws, rules, and regulations.

ARTICLE VIII

The name of the persons signing these articles of incorporation are David Luther Woodward.

ARTICLE IX

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
