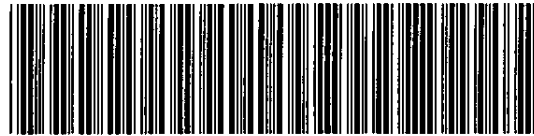

The Article of incorporation shall constitute a binding agreement and may be amended by the affirmative vote of majority of the Board of directors in office.
