

#### ARTICLES OF INCORPORATION

#### SCORE MARKETING, INC.

The undersigned, acting as incorporator of SCORE MARKETING, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## **ARTICLE I. NAME**
