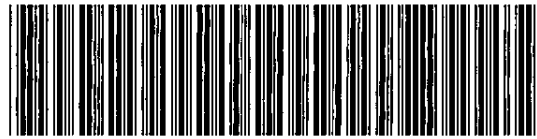

In Compliance with the requirements of F. S. 608.407, the undersigned, being a natural person, hereby acts in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") shall be Ruben's R & R Trucking, Company, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is 2202 North Johnson Road, Plant City, Florida, 33566 and its mailing address shall be 2202 North Johnson Road, Plant City, Florida 33566.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 100 par values \$.01 per share, all of which shall be Common Shares.
