**ARTICLES OF INCORPORATION OF**

**W. E. BISHOP, JR., P. A.**

**ARTICLE I - NAME**

**The name of this corporation is W. E. BISHOP, JR., P. A. The mailing address is 7743 SW S. R. 200, Ocala, Florida 34476.**

**ARTICLE II - DURATION**

**This corporation shall have perpetual existence.**

**ARTICLE III – PURPOSE**

**The purpose for which this corporation is formed are:**
