

# ARTICLES OF INCORPORATION OF WKE MEDIA, INC.



# **ARTICLE I. NAME**

The name of this corporation shall be WKE Media, Inc.

## **ARTICLE II. PRINCIPAL OFFICE**

The address of this corporation's principal office shall be: ECM #87274, 93 S. Jackson Street Seattle, WA 98104-2818.

## **ARTICLE III. MAILING ADDRESS**

## **ARTICLE IV. PURPOSE**

Any and all lawful business in the State of Florida.

#### ARTICLE V. CAPITAL STOCK
