The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming at LAHARY OF STATE corporation for profit under the Florida Business Corporation Act and in accordance with the STATE laws of the State of Florida, hereby adopts the following Articles of Incorporation.
