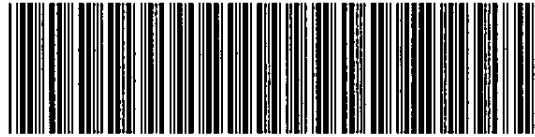

The name of this corporation is Worldwide Wade, Inc.
