

ARTICLES OF INCORPORATION
OF
HIDDEN OAK ENTERPRISES, INC.

I, the undersigned, the subscriber to these Articles of Incorporation, being a person of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is HIDDEN OAK ENTERPRISES, INC.

ARTICLE VI


The initial registered agent of this corporation shall be ALAN D. KALINOSKI, 617 Oak Circle, Oviedo, FL 32765.
