# Certificate of Incorporation of Comfort Castle Corp.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 5,000,000, of which 4,000,000 shares of par value \$0.001 per share shall be designated as Common Stock and 1,000,000 shares of par value \$0.001 shall be designated as Preferred Stock.
