TILED ARTICLES OF INCORPORATION OF BEACON CONSTRUCTION GROUP, INC. BEACON CONSTRUCTION GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Floridg General Corporations Act, hereby adopts the following Articles of Incorporation:

<u>ARTICLE I</u>

The name of this corporation, hereinafter referred to as the "Corporation", shall be: **BEACON CONSTRUCTION GROUP, INC.**

ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

This Corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and business of the Corporation as set forth in Article II.

ARTICLE IV
