ARTICLES OF INCORPORATION OF

(a Florida Corporation)

The undersigned, acting as incorporator of Fitness Just For You, Inc., proceeds to form a corporation under the Florida General Corporation Act, and adopts the following Articles of Incorporation:

#### <u>ARTICLE I. CORPORATE NAME</u>

The name of this corporation is Fitness Just For You, Inc.

#### ARTICLE II. STREET AND MAILING ADRESS OF PRINCIPAL OFFICE

The street and mailing address of the initial principal office is:

791 Heron Road, Weston, FL 33326.

#### ARTICLE III. CAPITAL STOCK (authorized shares)

- The maximum number of shares that the Corporation is authorized to have 1. outstanding at any time shall be One Thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid in whole or in part in cash or in other property, tangible or intangible, or in labor or services actually performed for the Corporation with a value, in the judgment of the Directors equivalent to or greater than the full par value of the shares.
  - 2. A shareholder shall be entitled to one (1) vote per common share on each matter

submitted to a vote at a shareholder's meeting. In the event of a dissolution of the Corporation, a shareholder shall be entitled to receive his or her proportionate share of the net assets of the Corporation based on a ratio of the shareholder's number of common shares to the total number of issued and outstanding shares.

3. No shareholder of the Corporation shall enter into a voting trust or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his or her shares.

#### **ARTICLE IV. PRE-EMPTIVE RIGHT**

Every shareholder, upon the sale in cash of any new stock of this Corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase a pro rata share thereof (as nearly but not over as may be done without issuance of fractional shares) at the price at which it is offered to others.
