
SPENCER BARON, whose address is 13762 W. State Road 84, Suite 135, Davie, Florida 33325, being duly sworn, deposes and states as follows:


2. The Non-Profit Corporation was recently dissolved, pursuant to a Certificate of Dissolution filed with the Office of the Florida Secretary of State.
